REPORT ON THE NOVEMBER WILPF BUSINESS MEETING

Five members attended the branch meeting on the early afternoon of November 16. Lucinda Tate replaced Jill Severson who has stepped down as convener.

Managing branch business this winter: Holly Hansen will collect branch mail from the WILPF mailbox in the First Unitarian Church office when the church office is open and move it to the WILPF office, where Anne will review it. Lucinda and Holly will log incoming phone calls and pass along information that requires a response.

Assisting Rep. Blumenauer's program advocating public and congressional support for HR 1506, the SANE Act: Portland WILPF is joining Oregon PSR (Physicians for Social Responsibility) in helping Blumenauer promote the Smarter Approach to Nuclear Expenditures (SANE) Act, intended "to reduce the number of nuclear-armed submarines operated by the Navy, to prohibit the development of a new long-range penetrating bomber aircraft, to reduce the number of intercontinental ballistic missiles operated by the Department of Defense." [See www.thomas.gov for details and text.] Blumenauer wants our help in planning a public forum on the SANE act in Portland early next year.

Next Meeting: There will be no business meeting in December. During early 2014 our business meetings will be held on the third Saturday of each month, 1 to 3 p.m.

- 1. Engaging as many WILPF members as possible in supporting the Nuclear Abolition Treaty. It currently has the endorsement of 125 UN member states—but not of the US.
- 2. Participating in and financially supporting a <u>hemispheric</u> Women, Peace, and Security strategy meeting in Bogota, Colombia.
- 3. Emphasizing intergenerational mentoring during the next 3 years as we strengthen our programs for involving students and WILPF branch members in Advocacy at the UN.

WILPF MEMBERS SPEAK TO GEORGE FOX UNIVERSITY CLASSES

On November 11, Lucinda Tate and I gave presentations for two Global Issues classes for seniors at George Fox University in Newberg, OR. The first class was videotaped for use at the university. Lucinda gave excellent handouts with her overview of the history and current work of WILPF, including work toward ending human trafficking and toward Congressional ratification of UN Security Council Resolution 1325 (www.un.org/womenwatch/osagi/wps).

I discussed the historical and contemporary status of women in Cuba, after showing the trailer for the film MAESTRA (<u>www.maestrathefilm.org</u>) about the Cuban literacy brigades of the early 1960s. WILPF is promoting the showing of this film and has just co-sponsored a 10-day delegation to Cuba, November 22-December 1, to participate in the VII International Conference on "Women in the 21st Century". <u>http://www.womenandcuba.org/</u>

Overall, I feel our time was well-spent, and we provided the students much food for thought. Prof. Paul Otto told us we were better prepared than some speakers in the quarter's series of weekly classes, and two students thanked us for our longtime activist commitments.

ARMISTICE DAY VFP/WILPF RALLY AT PIONEER SQUARE

Portland's Veterans for Peace Chapter 72 members led the rally on Veteran's Day to commemorate the armistice signed on 11 November 1918. VFP continues the traditional Armistice Day celebration in order to proclaim the continuing desire for a world without war.

Holly Hansen heard Lucinda Tate speak at the rally. Holly says she was moved to tears by Lucinda's words about her family's veterans. Here's Lucinda' brief summary of what she said:

A PEACEFUL RESPONSE TO FAMILY VETERANS

A reflection by Lucinda Tate on behalf of her brother Bobby

My dilemma in my family is that I do not believe in war but support my family members who are veterans—father in WWII, brother in Korean War, and brother in Viet Nam. I made a commitment to work for peace in my own life and not discuss the pros or cons of war with my military family members. It was very hard not to express my views when I saw the lies told by the government and social media concerning the reasons why the US was sending troops to the various military campaigns. Now, this year, on January 13, 2013, my last remaining family military member has gone to his final resting place, and I am free of my promise to not speak up against military involvement in countries that have not asked for and do not want our involvement in their internal conflicts. We should be the peacemakers of the world instead of the global police. I respect all veterans for their unselfishness, and I support the work of the Veterans for Peace. Peace be with each and every one of you. Thank you.

DECEMBER 10 IS HUMAN RIGHTS DAY

December 10, 2013, is also the 20th anniversary of the creation of the United Nations Office of the High Commissioner for Human Rights. On this Human Rights Day, Portland, Seattle, San Francisco, Los Angeles, and New York will join the international movement to call for the release of Nestora Salgado, a brave indigenous woman and naturalized US citizen who has been in prison in Mexico since August 21. Her crime was helping people in her Mexican home town form a community police force to protect themselves from violent drug traffickers, criminal gangs, and unscrupulous officials. Join the 11 to 1 protest at the Mexican Consulate, 1305 SW 12th Ave at Morrison.

WILPF SUPPORTS ACTION AGAINST HUMAN TRAFFICKING

United Methodist Women (UMW), a faith organization with 800,000 members, is engaged in a campaign to raise awareness of the increased <u>human trafficking activities associated with the Super Bowl</u>. The Human Trafficking Subcommittee of WILPF's issue committee on Advancing Human Rights (AHR) will support this campaign in early 2014. Local actions of distributing flyers and postcards in January will be followed by a main action of leafleting at the Super Bowl site in East Rutherford, NJ, on February 2, 2014. CONGRESS MAY VOTE ON U.S.-AFGHAN SECURITY AGREEMENT

Senator Jeff Merkley and Representative Barbara Lee are trying to mobilize antiwar sentiment to force an up-or-down vote on the Afghan agreement. "The possibility of a military presence into 2024 is unacceptable," says Lee. "There is no military solution in Afghanistan. After thirteen years and more than \$778 billion invested in an unstable country and the corrupt Karzai government, it's time to bring our troops and tax dollars home."

"Americans concerned about endless war in Central Asia ought to let members of Congress and the White House know that what's working with Syria and Iran ought to work for Afghanistan too," writes Bob Dreyfuss (<u>http://www.thenation.com/article/177388/block-us-afghan-security-agreement</u>).

SPEAK YOUR MIND ON NEW "WOMEN'S HEALTH PROTECTION ACT"

We need a federal law that protects a woman's access to all reproductive health care services, including abortion, and stops politicians from interfering in personal, private medical decisions.

S 1696, the Women's Health Protection Act of 2013, was introduced by Senator Richard Blumenthal (D. Conn) on November 13. It has 32 co-sponsors, including both senators from Oregon. The same bill, introduced as HR 3471, has 77 co-sponsors in the House, including only Blumenauer and DeFazio from Oregon to date. According to the Huffington Post, "Blumenthal's bill wouldn't automatically overturn states' anti-abortion laws, but because federal law trumps state law, it would provide a means to challenge them in court. The bill would direct judges to consider certain factors in determining whether a restriction is legal, such as whether it interferes with a doctor's good-faith medical judgment, or whether it's likely to interfere with or delay women's access to abortion."

The bill is pending committee action in both houses. Let your voice be heard!

THE SAFE SCHOOLS IMPROVEMENT ACT of 2013

Many state laws prohibit school-based bullying, but some do not explicitly cover harassment of LGBT students. Harassment or bullying based on sexual orientation is not covered under civil rights laws. To ensure that schools take action to demonstrate their commitment to the wellbeing of all students, the Safe Schools Improvement Act (SSIA) would require that states and school districts develop comprehensive anti-bullying and harassment policies that include all students. Go to <u>www.thomas.gov</u> to follow the progress of S 403 in the Senate and HR 1199 in the House, and urge your members of Congress to support it.
