GLOBAL DETROIT: WOMEN, DEMOCRACY AND CORPORATE POWER WILPF US Section Triennial Congress, July 31-August 3

Two Portland branch members are preparing to spend the first weekend of August in Detroit, Michigan. **Carol Urner** and others in her national Disarm committee will present a workshop on "Abolishing Nuclear Weapons in Our Lifetime." **Lucinda Tate** (that's me, I'm co-chair of the WILPF Advancing Human Rights committee) is busy reviewing proposed workshops related to AHR issues and approving content of a sponsored workshop for Congress. It's only my second Triennial, and my excitement is rising! This Congress lays the platform on which we prepare for the 2015 celebration of WILPF's 100th year. FIRST 2014 ISSUE OF PEACE AND FREEDOM IS OUT (and online)

Current members of WILPF US have recently received the spring/summer issue of the magazine. The issue reports on the role of WILPF's 75-member international delegation at the UN 58th annual session of the <u>Commission on the Status of Women</u> (CSW) last March. Patricia Hynes, retired nuclear engineer, gives her reasons for supporting "a nuclear-free, zero-carbon renewable energy future." Efforts to achieve a ban on nuclear weapons are addressed in three articles, Detroit's disruption in two, and the little-known Haifa Conference on creating a Weapons of Mass Destruction and Nuclear Weapons Free Zone in the Middle East gets a full presentation. GLOBAL WARMING: TALKING CARBON TAX

Oregon Congressman Peter DeFazio, a senior member of the House Transportation and Infrastructure Committee, introduced HR 4848, the <u>Repeal and Rebuild Act of 2014</u>, on June 11. This bill would replace the gasoline tax with a tax on crude oil in order to get more revenue for the Highway Trust Fund. The bill is in the House Ways and Means Committee.

Oregon Climate (www.oregonclimate.org) is a grassroots initiative anticipating that last year's passage of SB 306 offers an opportunity to urge the Oregon legislature to consider and pass a carbon fee and dividend bill, establishing an <u>Oregon carbon tax</u> modeled on the one successfully in force in British Columbia. SB 306 provided funds to determine how such a tax would affect various economic and geographic segments of Oregon. British Columbia redistributes some of the revenue from the tax in the form of corporate tax cuts, low-income tax relief and targeted investments in certain industries. BLUMENAUER FORUM ON NUCLEAR WEAPONS, JUNE 4

As an overflow crowd kept pouring in, First Unitarian's social justice minister, Kate Lore, set the context of the forum with her opening words of welcome. She told us that the US is spending more on nuclear weapons today (at minimum a half trillion over the next ten years) than at the height of the Cold War, also citing evidence that the Congressional Budget Office cannot be sure that this accounting is even accurate.

Congressman Earl Blumenauer then took over as genial host of his forum. He spoke briefly about his bill, HR 4107, the Reduce Expenditures In Nuclear Infrastructure Now (REIN-IN) Act, voicing great concern about recent evidence of the looseness of our control over the 450 nuclear missiles held continually on high alert, ready for launch. He talked at more length about his concern over the care available to returning veterans. To meet this challenge, he said, will require several trillion dollars because "we haven't scaled up the Veterans Administration for our reckless military interventions."

Calling Carol Urner forward, Rep. Blumenauer presented her with a Lifetime Achievement Award for her decades of work toward nuclear disarmament. See the citation below.

Kelly Campbell, executive director of Oregon Physicians for Social Responsibility, led off the panel with figures showing that nuclear abolition is also a budgetary issue. Rick Wayman, director of Programs and Operations at the Nuclear Age Peace Foundation (NAPF), sounded a hopeful note about growing international action toward abolition. The International Campaign to Abolish Nuclear Weapons (ICAN, <u>www.ican.org</u>) now has member groups in 48 countries. In April the Republic of Marshall Islands (RMI) filed a lawsuit in the International Court of Justice against the nine nations with nuclear weapons. See <u>www.nuclearzero.org</u> to sign a petition supporting RMI's goal—enforcement of these nations' obligation to begin negotiations for complete disarmament.

Dr. John Pearson, past president of Oregon PSR, described the consequences of even a small nuclear war for climate and agriculture. The following decade of decreased food production would be devastating, he said, and no adequate response is possible. It must be prevented. Dan Serres, conservation director for Columbia Riverkeeper, reminded us that the risks of nuclear technology are very clear at the Hanford Nuclear Reservation, upstream from Portland. Hanford Challenge (www.hanfordchallenge.org) publicizes the activity and problems of this ongoing cleanup.

The vigor, excitement, and persistence of the question and answer period showed vividly how much audience members appreciated the opportunity this forum provided for discussion of a crucial topic rarely talked about publicly nowadays.

LIFETIME ACHIEVEMENT AWARD: CAROL URNER

For decades, Carol Urner has advocated for nuclear disarmament and human rights, both in the United States and abroad. In the 1950's, Carol worked on nuclear issues as the American Friends Service Committee's Chicago Peace staffer. She co-founded Women for Peace, an organization dedicated to securing the first nuclear test ban treaty and bringing women into leadership. While living abroad with her husband, she worked to improve the delivery of aid to some of the world's poorest citizens. Today Carol is a dedicated leader in US WILPF's Disarm committee, where she actively pursues the vision for a nuclear weapons free world.
