SHOW YOUR SUPPORT FOR NUCLEAR WEAPONS REDUCTION JUNE 4

Congressman Earl Blumenauer invites you to a forum on "The Risks and Costs of Nuclear Weapons" in the early evening of Wednesday, June 4. Come to the Buchan Reception Hall, First Unitarian Church, at 5:30 pm for a half-hour Information Fair featuring WILPF, Oregon PSR, and other organizations. The program will begin at 6 pm with a welcome from First Unitarian and Congressman Blumenauer's opening remarks about the legislation he has introduced in the US House of Representatives to "rein-in" nuclear weapons spending.

HR 4107, the Reduce Expenditures in Nuclear Infrastructure Now (REIN-IN) Act, would save \$100 billion over the next 10 years by reducing or eliminating unnecessary nuclear weapons programs, and the act will increase Americans' safety by cutting from 450 to 150 the number of intercontinental ballistic missiles currently on 24-hour high alert. HR 4107 has 13 cosponsors, including Rep. **Peter DeFazio** of Oregon. Senator **Jeff Merkley** is co-sponsor of the companion bill, **S 2070**, introduced in the Senate by Sen. Ed Markey of Massachusetts.

After outlining the benefits of this legislation, Rep. Blumenauer will honor WILPF member **Carol Urner** with a Lifetime Achievement Award for her activism on nuclear weapons with the WILPF-US DISARM/End War issue committee and the Oregon PSR Peace Work Group.

A panel discussion on the fiscal, humanitarian, and environmental legacy of US nuclear weapons programs will follow. Panelists are Kelly Campbell (Oregon PSR), Rick Wayman (Nuclear Age Peace Foundation), Dr. John Pearson (Oregon PSR), and Dan Serres (Columbia Riverkeeper). The final half hour will be devoted to Q&A between audience and speakers.

REP. BONAMICI TOWN HALLS JUNE 6-14

Voters in Oregon's 1st Congressional District will have ample opportunity this month to urge Representative Suzanne Bonamici to become a co-sponsor of Blumenauer's REIN-IN Act. 350PDX INVITES YOU TO THE "CRUDE AWAKENING OIL TRAIN TOUR"

We all need to wake up and see what's threatening our beautiful, bountiful northwestern states!

Two years ago in the Pacific Northwest, there were no terminals prepared to handle mile-long trains of crude-oil-filled tanker cars. Today, four terminals are operating in Washington and Oregon, with six more in various stages of permitting and construction.

These terminals are designed to handle volatile Bakken crude—noted for having exploded last year in North Dakota, in Alabama, and in Quebec, where 47 people lost their lives—as well as Alberta tar sands bitumen, phenomenally difficult to clean up from watery places. Add the push by the American Petroleum Institute to lift the ban on US crude exports, and it's clearly past time to address the question posed by the tour: Is this really for us?

HELP PUT GMO FOOD LABELING ON THE OREGON BALLOT

Oregon Right to Know is circulating petitions to qualify its GMO Labeling Initiative for the November 2014 ballot, and you can actually submit your signature on an E-Petition. Oregon law allows a voter to download and print a special single-signer initiative petition, fill out and sign the petition, and then mail it to the chief petitioner of the measure. PROTEST THE USDA RULE CHANGE THAT WEAKENS ORGANICS

"The growing organic market presents a temptation for business interests in the organic industry to look for ways to lower costs and gain bigger market share, including by <u>lowering standards</u>. Organic pioneers and watchdog groups like the Organic Consumers Association and the Cornucopia Institute allege that the U.S. Department of Agriculture (USDA) is <u>capitulating to corporate interests</u> and reversing 20 years of precedent by removing the ability of the National Organic Standards Board (NOSB) to effectively decide the working definition of the organic food production system." (Rebekah Wilce, "Are Organic Standards in Jeopardy")

The 1990 Organic Foods Production Act (written by Senator Patrick Leahy and Representative Peter DeFazio) authorized NOSB to allow certain synthetic or non-organic materials (such as use of antibiotics like tetracycline on apple and pear trees) to be included in organic agriculture on a temporary basis. These "exemptions" were reviewed every 5 years and automatically removed unless the NOSB voted to retain them for another 5 years.

Last fall, without any process of full public notice and comment, the USDA changed the rules to allow such "exemptions" to continue permanently unless the NOSB intervened with a supermajority vote of 2/3 of its members. Senators Leahy and DeFazio, along with three former chairmen of the NOSB, have protested the Department of Agriculture that this policy change is "in conflict with the letter and intent" of the original 1990 statute.

"Organic watchdog groups like the Organic Consumers Association and Cornucopia Institute are asking supporters to tell Agriculture Secretary Tom Vilsack to reverse the rule currently weakening organics."
