NEWS from the WILPF PORTLAND MEETING on SEPTEMBER 10

<u>Members Present</u>: Barbara Drageaux, Celeste Howard, Anne McLaughlin, Sandra Oberdorfer, Teisha Parchment, and Brandy Robinson, presiding.

<u>Treasurer's Report</u>: Anne reported income and expenses for the past two months, including an unexpected sum from the Jane Addams Peace Association (JAPA), a non-profit affiliate of WILPF US to which tax-exempt donations were formerly sent. The money was donated to support WILPF peace work led by Portland member Yvonne Simmons during the Bosnian War (1992-1995). Though designated for the Portland branch, it was never mailed to us.

<u>Endorsement</u>: A two-page summary of the Multnomah County Measure 26-184 (Honest Election) was given to everyone. After discussion, we agreed to sign WILPF Portland on as an organizational endorser of this measure. <u>Clarifying Our Membership List</u>: The WILPF US national office has sent us its official list of Portland branch members. It will help us identify the newsletter recipients who have become WILPF members by sending annual dues to the national office in Boston. **Sandra** is getting ready to create a new branch directory, and she will have help from Anne, Brandy, and Teisha in bringing local information up to date. She hopes we can schedule at least three social events a year for outreach to membership. The membership list from WILPF US will also assist us in sending a fall fundraising appeal letter to past and present supporters.

<u>Proposed Branch Internship</u>: Brandy has talked with Dr. Tom Hastings in the PSU Conflict Resolution Program about offering a paid internship to a student for working a few hours a month during the academic year on a WILPF Portland project. He will contact potential candidates and coordinate with the branch.

<u>Notable Woman Report</u>: Brandy heard Monique Morris, co-founder and president of the National Black Women's Justice Center in Berkeley, at a recent Portland event. Dr. Morris talked about her new book, *Pushout: The Criminalization of Black Girls in Schools* (http://www.moniquewmorris.me/). Brandy found Dr. Morris extremely impressive and recommends the book to everyone.

Natasha Beck attended Western States Center's Reproductive Justice Conference at First Unitarian Church in August. Participants from several western states included social service workers and activists from Planned Parenthood, NARAL-Pro-Choice, and other groups. Talking about Reproductive Justice provides a broader focus than talking of Reproductive Rights.

AUGUST 6 WEBINAR on NUCLEAR WEAPONS ABOLITION

WILPF AUSTRALIA originated the webinar "A Nuclear Weapons Free World" on the morning of August 6, the 71st anniversary of Hiroshima Day. For European participants it was 9 pm on August 5, for WILPF Portland it was noon. The recording of this webinar is now available on line at https://www.youtube.com/watch?v=RgELote_Ptc. In the lower right corner of the youtube video screen, click on "CC" if you wish to display closed captions. The captions are helpful, but not perfect.

Helen Caldicott is the first speaker (minutes 3:50 to 15:30 on the recording). Listen to her carefully, for she describes the present wide distribution of deployed 'nukes' and the devastating effects of firing any one of them. "If America doesn't do the right thing," she says, "I think we are doomed," after explaining how the US is provoking Russia in the Ukraine, how both the US and Russia are nervous about a first strike advantage, and how the US is planning to spend \$1 trillion to 'modernize' its nukes and their delivery system.

Daniel Högsta is Network Coordinator for ICANW, International Campaign Against Nuclear Weapons, in Geneva. Listen to him (minutes 17 to 33:30) for awareness of what is happening <u>now</u> in this very active campaign—a shift toward humanitarian considerations in talking about nuclear weapons has drawn political support from 155 nations, spurring civil society to find new legal pathways to nuclear disarmament. Humanitarian initiatives have led to the banning of land mines and cluster bombs. A new treaty which prohibits the possession, deployment, stockpiling and threat of use of nuclear weapons could ban these weapons.

Such a treaty must be achieved by a process "open to all and blockable by none." Therefore, formation of an Open Ended Working Group (OEWG), open to all governments was proposed by a UN resolution and authorized to identify provisions and norms for effective legal measures. Its recommendations have been compiled in its report, and the OEWG voted its majority approval on September 6, as shown in this photograph. Next step: The



report goes before the United Nations General Assembly where a majority vote would start the negotiations on a treaty to ban nuclear weapons. Those negotiations could begin as early as next year. Go to www.goodbyenuk.es to urge US government support for this ban!

Ray Acheson is Director of Reaching Critical Will, WILPF's disarmament programme. At the UN she is also the NGO and WILPF liaison and coordinator for nuclear disarmament. She talks (minutes 35 to 53) about the broad context surrounding talk about nuclear weapons. The resistance of nuclear states in the OEWG (they call themselves "progressive") to a ban usually comes from the desire to retain power, exercise political advantage, or support particular money interests. Cultural inequalities based on class, race, and gender often play an unconscious role. We need to "make the playing field level for everybody!" She then focuses on the role of sex and gender in talk about nuclear weapons, views on their contribution to security as deterrents, attitudes toward their potential use, and differential effects of their detonation on male and female bodies of survivors.

A Q&A session follows in which each speaker was invited to suggest ways to support the ban. Questions from webinar participants were then discussed, ending at 1 hour, 32 minutes.



Theme for 2016: CHOKEHOLD ON RUSSIA AND CHINA

Why is the U.S. Provoking Global War?

This Map and Text come from the 2016 Keep Space for Peace poster. Commentary is below.



The U.S. & NATO are increasing their military encirclement of Russia and China. After the fall of the former Soviet Union the U.S. promised not to expand NATO toward Russia. That promise has been repeatedly violated by the west.

Today U.S. 'missile defense' systems (MD), key elements in Pentagon first-strike attack planning, are being deployed on the ground and at sea around Russia and China. Nuclear disarmament negotiations have ground to a halt due to these U.S. MD deployments.

Help stop this new dangerous Cold War from igniting into a deadly hot war. Join us by holding local events during space week. Demand true peace and conversion of the military industrial complex to help deal with the coming reality of climate change.

Tension between US & Russia has grown since the 2014 coup in Ukraine. Margaret Kimberley (http://www.commondreams.org/views/2015/02/12/us-war-peace-ukraine) tells how the 'new Cold War' started in her article from Black Agenda Report. The map above shows both why disarmament negotiations have stalled and why a treaty to ban nuclear weapons is essential for a secure and lasting peace.

The war has never ended, with ongoing US military operations including airstrikes and drone raids, and a promised withdrawal of troops that has been scaled back and cancelled. As he fights to reconcile his country's betrayal with his passionate belief in the U.S. Constitution, Hirabayashi journeys toward a greater understanding of America's triumphs — and a confrontation with its failures. Sunday 9 October, 10 am to noon: "Vision and Vigilance: Minoru Yasui, an Oregonian Civil Rights Hero"

Portland Center Stage, 128 NW 11th Ave. at Davis St. Selected scenes from Holly Yasui's play "Citizen Min," about her father, Minoru Yasui, a Japanese American born in Hood River in 1916. He was the first Japanese American to graduate from University of Oregon School of Law and to pass the Oregon bar. During World War II, he challenged the first military proclamation discriminating against Japanese Americans, a curfew authorized by President Roosevelt's Executive Order 9066, which resulted in the forced removal of 120,000 Japanese Americans from their homes in western Oregon and Washington, and the entire state of California. He was imprisoned in the Multnomah County Jail for 9 months in solitary confinement awaiting his appeal to the U.S. Supreme Court, which ruled against him in 1943. This reading will be followed by roundtable discussions.
